Terms & Conditions

- 1. Boustead Petroleum Marketing Sdn Bhd ("BHPetrol")'s *Peraduan Hari-Hari Menang!* ("the Contest") is open to all customers and/or new and existing eCard and eCard App members aged 18 years and above at participating BHPetrol service stations
