## **'PAM & MENANG LAGI DI BHPETROL' CONTEST 2022**

## Terms & Conditions

- 13. In the event if a Shortlisted Contestant(s) is unreachable via telephone, BHPetrol shall reserve the right to select another Shortlisted Contestant(s). The next-in-line Shortlisted Contestant(s) shall be contacted and may, potentially, be rewarded with the Prize.
