

“Win Special Gadget every month!” 2022

TERMS AND CONDITIONS

Organiser and Eligibility

The “Win Special Gadget every month” 2022 (“Contest”) is organized by Boustead Petroleum Marketing Sdn Bhd [196401000488 (5783-T)] (“Organiser”).

By participating in this Contest, you agree to comply with all terms and conditions set forth herein.

1. This Contest is open to all Malaysians who are aged eighteen (18) years old and above (“Contestants”). All Contestants are required to be BHPetrol eCard app member to be a valid entrant.
2. The following categories of Contestants are **NOT ELIGIBLE** to participate in this Contest:
 - a. Permanent/contract employees of the Organiser and/or its Affiliates;
 - b. The Organiser’s service station dealers;
 - c. Employees of advertising and promotional agencies for the Organiser and/or its Affiliates; (hereinafter collectively referred to as “Non-Eligible Contestants”); and
 - d. The immediate family members (ie father, mother, spouses and or child/children) of the Non-Eligible Contestants.

“Affiliate” shall mean each of its subsidiaries, holding companies and subsidiaries of such holding companies.

3. The Contest period runs from 1 January 2022 to – 31 December 2022.
4. The Organiser reserves the right to terminate, change, amend, delete and or add to these Terms and Conditions at any time without prior notice.
5. The Organiser shall not be held liable for any loss, damage and or expense for any reason(s) whatsoever.
6. The Organiser’s decision shall be final and binding. No correspondence will be entertained.
7. By entering into the Contest and by accepting the prize, all winners agree that the Organiser has the right to photograph, picture, voice record and or portray them as contest winners in any manner whatsoever as the Organiser may in its absolute discretion decide, and to exhibit these materials for all contest-related advertising, marketing and or publicity purpose(s) without any notice, payment, fee, compensation or consideration whatsoever, subject to the applicable laws and regulations.

How to Participate

 - a. be a valid eCard app member;
 - b. earn (1) contest entry during the month for every accumulated spend of RM 30.00 (excluding utility bill payment, reload service and carwash service) at participating BHPetrol stations with eCard acceptance;
 - c. ensure station staff can the QR code from customer's eCard app;
2. Eligible members will be automatically enrolled to participate in the contest.
3. New eCard app member during the month will also be entitled to one (1) entry for every eligible cumulated spending of RM 30.00 during the month
4. The Organiser shall not be held responsible for any Internet connection error that may affect the Contest.

Judging Criteria

1. Contestants can earn as many contest entries as possible every month.
2. Based on all entries received, the Organiser will then begin to select the required number of Contestants ("Shortlisted Contestants") every month. The Organiser's decision on all matters relating to this Contest (including the selection of Shortlisted Contestants) shall be final and binding. No correspondence relating to the selection of winners will be entertained.
3. After the Contestants are shortlisted every month, winners will be chosen at random:
 - a. One (1) grand prize winner;
 - b. Four (4) consolation prize winners.
